I, (We) understand that a Special Inspector inspection log for each building must be displayed in a convenient location on the site for reference by the City of Homestead Building Inspector. All mandatory inspections, as required by the Florida Building Code, must be performed by the City. Inspections performed by the Special Inspector hired by the Owner are in addition to the mandatory inspections performed by the City of Homestead Building Inspector. Further, upon completion of the work under each building permit, a completed inspection log and a sealed statement of inspection indicating that, "To the best of my knowledge, belief and professional judgment that those portions of the project outlined above meet the intent of the Florida Building Code and are in accordance with the approved plans", will be submitted to the Building Inspector at the time of the final inspection.
